

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.275903 per \$100 valuation has been proposed by the governing body of Del Mar College.

PROPOSED TAX RATE:	\$0.275903 per \$100
NO-NEW-REVENUE TAX RATE:	\$0.275081 per \$100
VOTER-APPROVAL TAX RATE:	\$0.284986 per \$100

The no-new-revenue tax rate is the tax rate for the 2026 tax year that will raise the same amount of property tax revenue for Del Mar College from the same properties in both the 2025 tax year and the 2026 tax year.

The voter-approval rate is the highest tax rate that Del Mar College may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Del Mar College is proposing to increase property taxes for the 2026 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 25, 2026 AT 12:00 PM AT Center for Economic Development, Del Mar College, 3209 S. Staples, Room 106, Corpus Christi, Texas 78411.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Del Mar College is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Del Mar College at their offices or by attending the public hearing mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Del Mar College last year to the taxes proposed to be imposed on the average residence homestead by Del Mar College this year.
