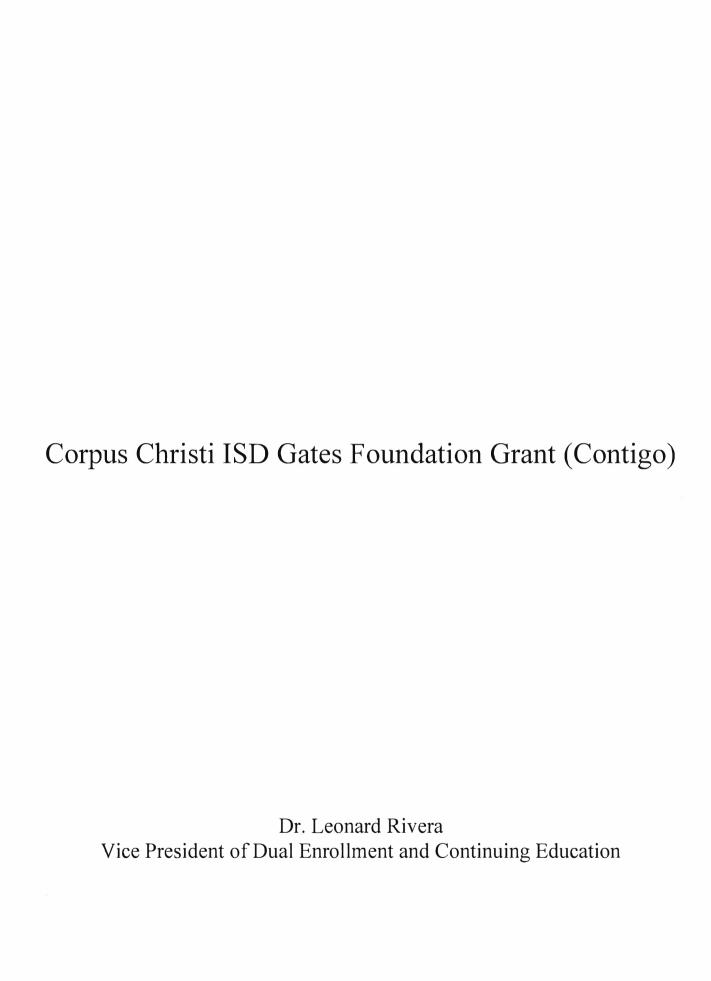

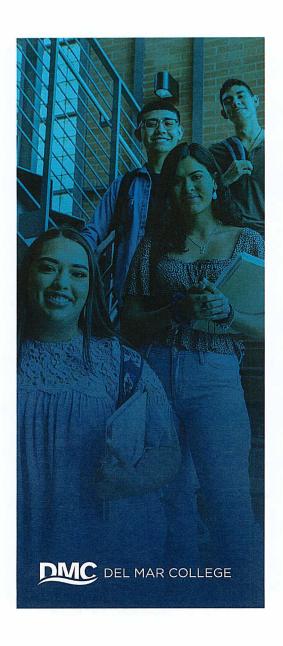

# Corpus Christi ISD Gates Foundation Grant (Contigo) Purpose

Increase the percentage of students successfully transitioning from high school to an institution of higher education to earn a credential of value.

#### **Key Outcomes**

#### 1. Early College Coursework Access:

- Increase percentage of students in early college coursework.
- Student enroll in at least 15 credit hours.

#### 2. Early College Coursework Attainment:

- 3. Dual Enrollment: Create coherent pathways for high school students to access college coursework aimed towards the achievement of credentials of value and remove all related barriers that may prevent access to these pathways.

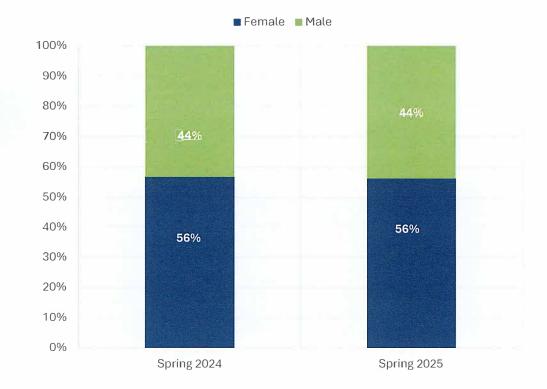


# Overview and Leading Indicators for Funding Under House Bill 8

- House Bill 8 rules remain a "work in progress."
- Student headcount is trending upward
  - Credit headcount increase of 6.2% (spring 2024 to spring 2025preliminary)
  - Dual credit headcount is trending upward (1-year:10.2% increase, 5-year: 29.6% increase, and 10-year: 106.2% increase)
  - Continuing education headcount increase of 41.8% (spring 2023 to spring 2025-preliminary)

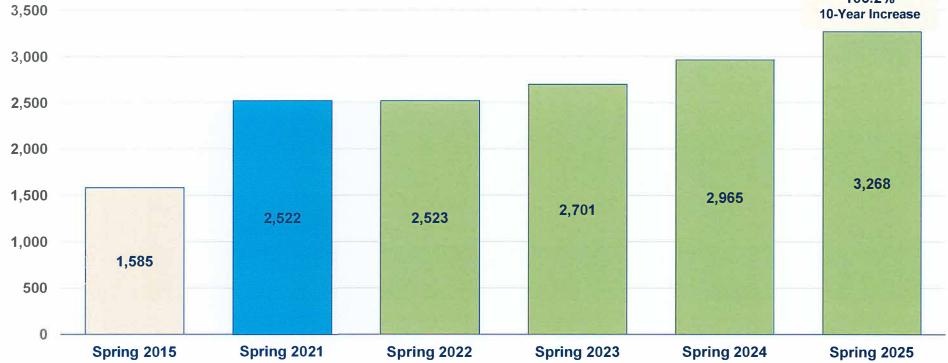

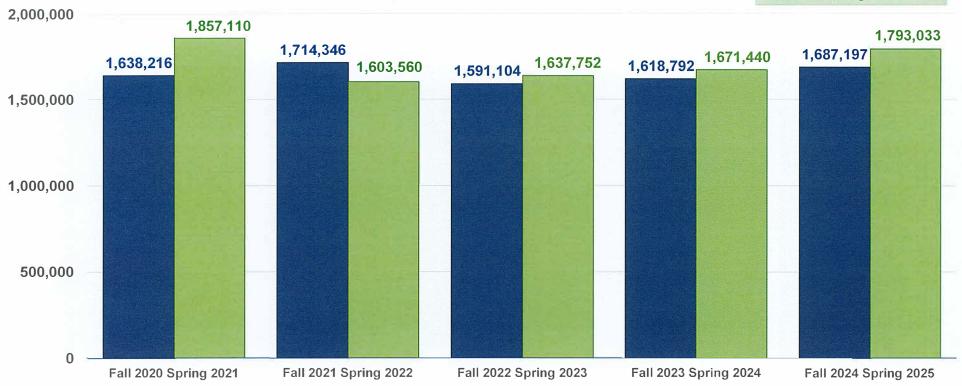

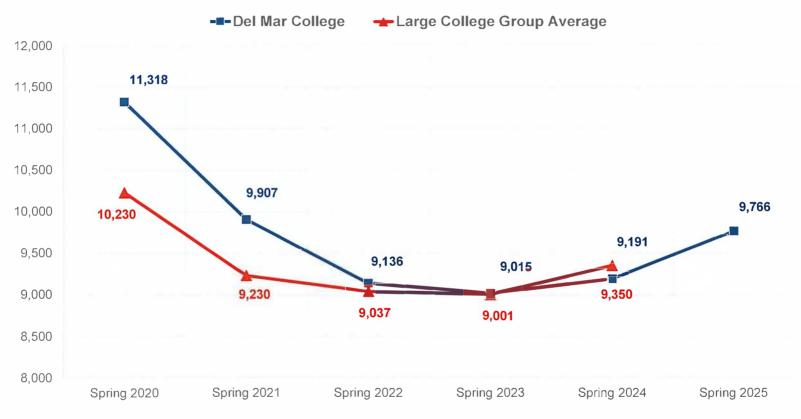

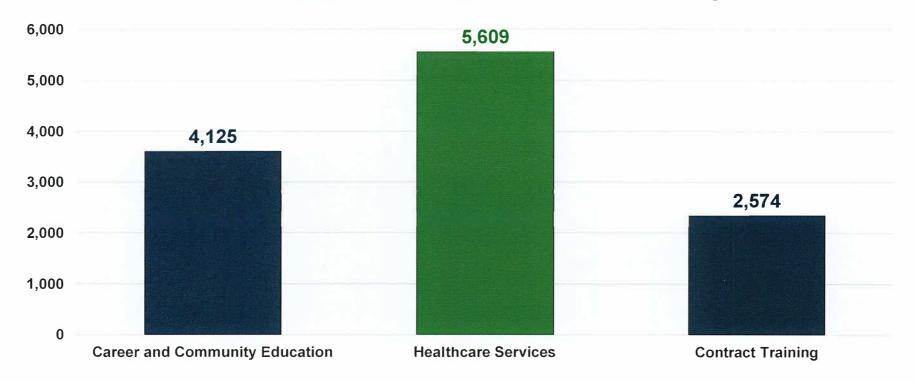

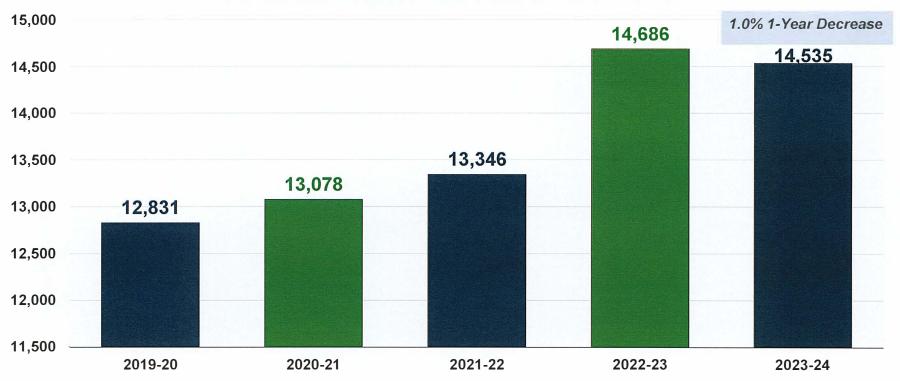
## **Continuing Education: Largest Programs by Enrollment**

# Total Annual Enrollments in Continuing Education Courses for the Academic Year



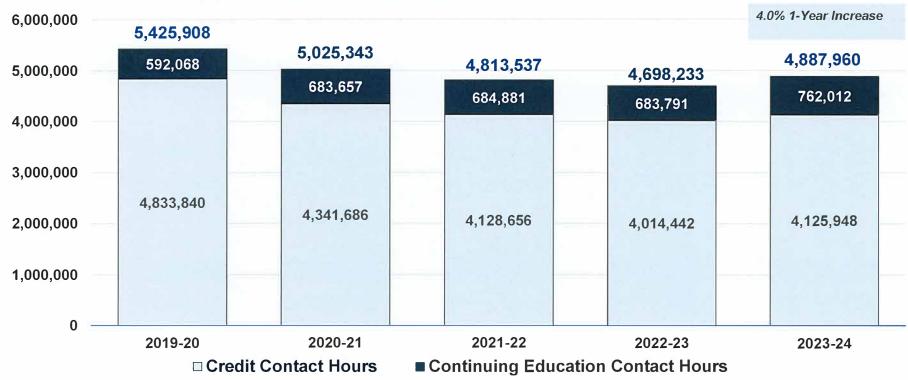

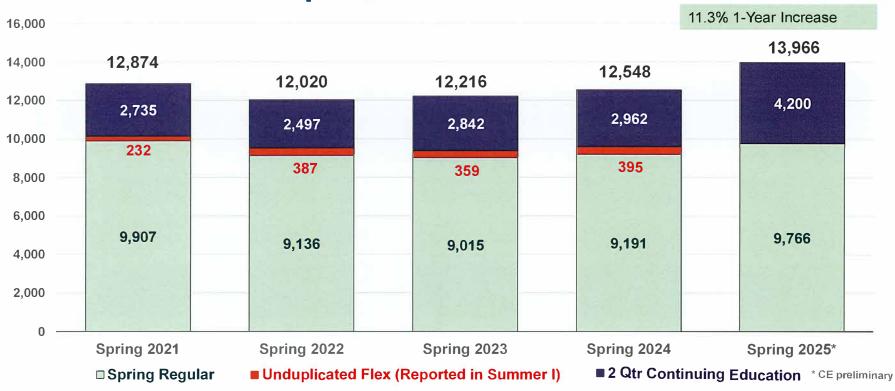
# Total Annual Contact Hours for Credit and Continuing Education Courses for the Academic Year

# Five ways a funding overhaul has transformed Texas community colleges

More than a year after Texas' House Bill 8 took effect, some schools have offered free tuition, grown dual credit programs or helped students' credits transfer when they move on to four-year schools.

Community colleges in 2023 celebrated a long-awaited investment from the Texas Legislature, positioning Texas to lead the country in connecting young people to the workforce.

That year, state legislators reimagined how community colleges are financed with House Bill 8. The old funding formula awarded schools based on enrollment. Schools now have to see their students through to graduation to get money: The new formula ties state dollars to degree and certificate completions, transfers to four-year universities and high schoolers' participation in dual credit courses.

The effort was born out of state leaders' desire to better prepare young Texans for the workforce. By 2030, at least 60% of jobs in Texas will require a postsecondary credential, and yet, less than 40% of students earn a degree or certificate within six years of graduating high school. For students, a postsecondary credential often leads to higher wages and increased economic and social mobility.

As part of a near-unanimous vote for HB 8, lawmakers poured a historic \$683 million into two-year institutions. When the money trickled down to each college in fiscal year 2024, each college saw an influx of dollars that ranged from \$70,000 to \$2.9 million.

Over a year after the law went into effect, community colleges have been working with unprecedented resources to bring down barriers to completion. Some have introduced free tuition benefits; others have expanded their student advising services. Those efforts are reshaping how schools run and who is taking their classes.

"HB 8, at its heart, was an attempt for the Legislature ... to say, 'What's the most impactful way that we can ensure alignment between educational outcomes and business and industry needs?" Ray Martinez III, the president of the Texas Association of Community Colleges, said. "That's why this is so significant ... We have seen tremendous outcomes."

Lawmakers have been fine-tuning funding incentives this session. Rep. Gary VanDeaver, R-New Boston, is shepherding a bill that would give community colleges money for student transfers not only to public universities but also to private schools. Community colleges currently get bonus dollars when students complete credentials of value, or credentials that lead to high-demand, high-wage jobs: VanDeaver's bill would adjust the definition of a credential of value to include more precise labor market data.

Here are five ways community colleges have transformed because of the new funding formula:

#### **Dual credit boosts enrollment**

During the COVID-19 pandemic, young Texans cut community college out of their plans. One in ten students in the state — or about 80,000 students — disappeared from campuses.

Economic uncertainty acutely affected community college students, who often come from lower-income households and have more work and care responsibilities than their peers at four-year institutions. Many left school for low-skill jobs. Others lost the steam to keep going.

Community college leaders have had to find ways to keep students — and one big way has been growing the pool of high school students who get a jump start on college.

HB 8 makes it easier for low-income students to take dual credit courses. Community colleges in the Financial Aid for Swift Transfer program, or FAST, now get extra funding when they allow high school students who qualify for free and reduced-priced lunch to take classes at no cost. Other students get a discount, with a cap on costs at about \$55 per credit hour.

Research shows dual credit students are more likely to graduate from high school, enroll in college and finish their degrees faster.

The financial help has prompted an upshoot in enrollment. More than 250,000 students participated in dual credit classes through the FAST program in the 2023-24 school year, according to Sarah Keyton, who was the interim commissioner of the Texas Higher Education Coordinating Board last fall.

Kilgore College in East Texas, for example, saw a 36.5% increase in dual credit enrollment last school year. High schoolers now make up the majority of its student body.

Community colleges don't have to participate in the FAST program but nearly all have opted in. Colleges got a total of about \$80 million in extra funding last academic year, Keyton said.

College leaders are adapting to their schools' changing identities as dual credit students make up a larger portion of their total student populations. Some faculty now spend more time teaching in high schools than on campus.

#### Free tuition gains momentum

As young people increasingly question the value of college, a pair of colleges have come up with a new price tag: free.

In bold pilot programs, Austin Community College and Del Mar College are waiving three years of tuition for local high school graduates.

"'Discount' doesn't change people's perceptions that they can't afford to go to college," ACC Chancellor Russell Lowery-Hart told The Texas Tribune. "'Free' means something when you're talking about college affordability."

The first class of students to benefit from the <u>free tuition program</u> started this year. ACC paid for it with the \$6.8 million it received from the state last year through HB 8.

Lowery-Hart wants to use the program to reach students who were not planning to go to college. In a recent survey of ACC prospective students, more than half said they didn't enroll because of tuition costs.

When glitches in the revamped federal financial aid application delayed award packages, students in the Austin area told the Tribune that ACC's free tuition program was a much-needed option that eased the uncertainty.

Del Mar College is following ACC's footsteps, launching a free tuition benefit this fall for recent high school graduates and adult learners in the Corpus Christi area. Students have to enroll full time and maintain at least a 2.0 grade point average to qualify.

In what is known as a "first dollar" program, both Texas colleges are paying for students' tuition before federal and state aid kicks in. That allows students to use their grants and scholarship money to pay for other needs like housing, food and textbooks.

#### Students hired as peer mentors

Laredo College has turned nearly 80 students into peer advisers, multiplying its advising crew by seven.

The peer advisers are recent graduates, former students who transferred to a four-year university or current students who are finishing their degree. They help their classmates register for classes and stay on track to graduation.

Many Laredo College students are the first in their families to go to college. Young people in the region often opt not to get a college degree because they don't know how to go through the process — and there's nobody at home to help them, said Minita Ramirez, the president of Laredo College.

"Whether it's a first-time college student out of high school or ... a 70-year-old gentleman who all his life wanted to go to college, .... our hope is that we provide the support ... to get that person through the process, to make them feel comfortable in an environment that is completely foreign," Ramirez said. "And if we can do that, our numbers grow."

Already, Laredo College has seen 1,500 students switch from part-time to full-time, Ramirez said.

HB 8 has pushed college leaders like Ramirez to fix disjointed advising systems to prevent students from falling through the cracks. Research shows student advising is tied to <u>higher</u> grades and graduation rates.

When students at North Central Texas College register online for a course that won't count toward their degree, a warning sign now pops up encouraging them to visit an adviser. Chancellor G. Brent Wallace said he wants to make sure students don't sign up for the wrong course — and save them the time and money that goes along with those decisions.

North Central Texas College also hired about a dozen more staffers so advisers aren't stretched too thin and students get the academic attention they need, Wallace said.

#### **Growing workforce training**

Community colleges have long been a player in helping close workforce gaps, but HB 8 was the push for leaders to strengthen relationships with local employers.

Sherman, for example, has been grappling with its new identity as a semiconductor manufacturing hub. In recent years, giant companies like Texas Instruments and GlobiTech have been constructing multibillion-dollar chipmaking facilities.

Before those facilities could finish construction, Grayson College was already training students so they would be ready to join the industry.

Jeremy McMillen, the president of the college, said the school added programs like electronic and automation certifications with input from those companies. It mimicked the kind of collaboration the state's technical colleges have with employers on curricula.

"We needed to move the needle in terms of building out of the infrastructure," McMillen said at a Texas Tribune event last month. "Without HB 8 in the background, it's very difficult to imagine that we've been able to do that."

#### Schools team up so credits transfer

Students in North Texas are getting more support when they select Dallas College courses they want to count toward a bachelor's degree.

To ease transfers to local universities, Dallas College teamed up with Texas A&M University-Commerce, Texas Woman's University and the University of North Texas at Dallas to identify which courses students will get credit for when they transfer. The HB 8 funding model means the community college gets money when students successfully transfer.

Around 80% of students who enroll in community colleges intend to transfer but just 16% do, according to data from The Aspen Institute.

In the fall of 2022, more than 13,000 Texas students who transferred did not receive credit for at least one of the courses they completed, according to the Texas Higher Education Coordinating Board. Students lose time and money when they take classes that don't end up counting toward their degrees. The setback can discourage them from completing their bachelor's degree.

The Dallas-area schools launched an online portal in the fall where prospective students can see how their credits would be counted at each school and track their progress toward their bachelor's degree.

For three areas of study — business, education and health sciences — the universities have already agreed on which Dallas College courses will be counted for credit toward related majors on their campuses.

February 4, 2024

The Regular Meeting of the Board of Regents of the Del Mar College District convened on Tuesday, February 4, 2025, at 1:00 p.m., at the Center for Economic Development, 3209 S. Staples, Room 106, Corpus Christi, Texas with the following present:

#### CALL TO ORDER/QUORUM CALL

Chair Scott called the meeting to order with a quorum present. She requested a moment of silence followed by the Pledge of Allegiance and Del Mar College Vision Statement.

**GENERAL PUBLIC COMMENTS** – The public was given the opportunity to provide public comments (both general and specific to any agenda item).

There were no public comments.

• January 22, 2025: TACC Quarterly Meeting (I: Communicate, Goal 2: Connect beyond the College)

Dr. Escamilla attended the meeting virtually and stated the current 89<sup>th</sup> Legislative Session was heavy on the agenda with committees still being established.

• January 30, 2025: Aransas County Partnership Economic Summit (I: Communicate, Goal 2: Connect beyond the College)

Dr. Escamilla attended and participated in the Summit with other College attendees. Ms. Lenora Keas and other members of the community presented to a large group of attendees.

• January 30, 2025: Workforce Development Center Restoration Kick-Off, Rockport (1: Communicate, Goal 2: Connect beyond the College)

Dr. Escamilla stated that the kickoff for the Workforce Development Center Restoration. A second event will be held when the Center is ready to open.

• February 3, 2025: Community College Day (1: Communicate, Goal 2: Connect beyond the College)

Dr. Escamilla stated Community College Day at the Texas Capitol included 50 community colleges that participated to show the state's leadership to the students that attend and to give those students the opportunity to be heard. The College had 53 students, staff, and Regents Scott and Babbili in attendance.

#### REGENT'S REPORT:

Regent Kelly reported that his attendance at the Conference included a panel that Augustin Rivera, Jr., General Counsel was a part of, and a session stated discussing College's place in the community. He believes the College is well established with partnerships with industrial partners and attention to the local economy.

#### STAFF REPORTS:

Dr. Saumby provided background information and stated the College is accredited by SACSCOC for baccalaureates degrees, associate degrees, and certificates. Accreditation by SACSCOC signifies that the institution has a mission appropriate to higher education, has resources, programs, and services sufficient to accomplish and sustain that mission, and maintains clearly specified educational objectives to the degrees it offers, and that indicate whether it is successful in achieving its stated objectives.

Dr. Saumby reviewed accreditation standards that includes reaffirmation and 73 standards that occur every ten years and an Interim Report that includes 22 standards that occurs midway between reaffirmation. The topics in these standards include student achievement assessment, educational programs, student support services, financial and physical resources, and others. The administration team will be meeting regularly and will be providing updates up until submission in the fall of 2026.

Dr. Saumby responded to questions from the Board of Regents.

• Adult Education and Literacy Grant Update....Dr. Leonard Rivera and Ms. Rachel Benavides (II Elevate, Goal 1: Increase completion for all students)

Dr. Rivera provided an overview of the Adult Education and Literacy program which has been active since July 1, 2024. He stated that according to the Corpus Christi Literacy Council about 20% of the Corpus Christi population does not possess a high school diploma.

Ms. Rachel Benavides emphasized that the program is more than just a GED program and is a workforce development program, therefore operating under the auspice of the Texas Workforce Commission. The College received two Grants – High School Equivalency (HSE) program in the amount of \$895,000 with pending funding of \$38,000 being provided in March of 2025. The number of students to serve is 634 which includes 493 for adult basic services, 89 for integrated education and training, and 52 for intensive. The area includes counties in Aransas, Kenedy, Kleberg, San Patricio and half of Nueces County.

The second grant received for English as a Second Language (ESL) is to serve individuals who lack English fluency. The grant is in the amount of \$396,000. The ESL program has turned into a college and career readiness program. The number of students to serve is 297 which include 275 for adult basic service and 22 for integrated education and training. The counties include Aransas, Bee, Brooks, Duval, Jim Wells, Kenedy, Kleberg, Live Oak, Nueces, Refugio, and San Patricio.

Ms. Benavides stated the Integrated Educational Training (IET) is funding set aside to provide tuition support for short-term workforce training while concurrently enrolled in the adult education programs. The IET's are strategically aligned with House Bill 8. The Grant currently partners with Aransas Pass ISD, Goodwill Industries of South Texas, Gregory-Portland ISD, San Patricio County Literacy Council, and Workforce Solutions of the Coastal Bend.

Ms. Benavides, Dr. Rivera and Dr. Escamilla responded to questions from the Board of Regents.

Dr. Halcomb reported that the BAS-OML started in fall 2024 and acknowledged the team that assisted in preparing the program.

Dr. Sramek provided information of enrollment. For fall 2024, 258 students enrolled in the degree program and for spring 2025, 243 students were enrolled in the program. Dr. Sramek stated that 47 current college employees were also enrolled in the BAS-OML program in fall 2025 and for spring 2025 semesters, there are 60 current employees enrolled.

Dr. Sramek and Dr. Halcomb responded to questions from the Board of Regents.

Ms. McDonald provided introductory commentary. Ms. Jessica Alaniz provided an overview of the College's Policy Review Process. Every five years, College administration will perform review of policies according to the review schedule and make recommendations to the Board of Regents as necessary. For 2025, Chapters 9 and 10 are scheduled to be reviewed and other chapters that need review subject to changes in laws, statutes, or regulations as required.

Ms. McDonald reviewed the College's Chapter 9 (Prohibiting Sexual Misconduct/Title IX) and stated revisions to the policies and procedures are expected in the next few months as impacted by the new administration at the federal level. The College's Chapter 10 (Carrying Handguns on Campus by License Holder) has been reviewed and there are no recommendations for revisions. She also stated that Collegiate High School has moved into one building, and is designated automatically that you cannot carry in this building. The team will continue to monitor policies impacted by changes including executive orders and will be reviewed through the standards of SACSCOC.

• "A" Administrative procedure revisions in Chapter IX – Prohibiting Sexual Misconduct (III Cultivate, Goal 2: Optimize the student Viking experience)

Ms. McDonald provided an update regarding the location of A9.1.5.4 Counseling and Supportive Services regarding offices moving and their new locations on campus.

• DMC Police Department Racial Profiling Report Submission (III Cultivate, Goal 2: Optimize the student Viking experience)

Ms. McDonald provided an update of the requirements for the Texas Commission on Law Enforcement for filing a report regarding law enforcement racial profiling. The report was filed as exempt since the College does not make traffic stops in the routine performance of officer duties.

A vote was taken by show of hands, and the motion carried unanimously 9-0, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

  Dr. Patricia Benavides-Dominguez

  (II: Elevate, Goal 2: Maximize resources entrusted to the College)
  - A. Administration will present Governor Abbott's mandate regarding tuition;
  - B. Discussion and possible action regarding suspension of the automatic \$1 tuition increase per Board Policy B3.21; and
  - C. Timeline and discussion for proposed Pilot and Tuition Fee Waiver Program

Dr. Benavides-Dominguez provided information on Governor Abbott's November 13, 2024, tuition freeze mandate for all public institutions of higher education. This action prohibits increases in undergraduate tuition and fees for both the 2025-2026 and 2026-2027 academic years. She also stated that staff is recommending a suspension of the \$1 minimum increase in tuition per the College's B3.231 Tuition Policy.

Ms. Lenora Keas stated the team has been working diligently regarding the tuition waiver program and the details will be brought before the Board in the March meeting although a workshop may also be necessary to analyze options as well as a timeline.

Dr. Benavides-Dominguez, Ms. Keas, and Dr. Escamilla responded to questions from the Board of Regents.

Regent Crull made a motion to suspend the tuition increases for FY 25-26 and FY 26-27 academic years. Regent Kelly seconded the motion. There was further discussion from the Board. A vote was taken by show of hands, with 6 voting in favor by Regents Scott, Adame, Crull, Kelly, Garza, and Turner, and 3 voting against by Regents Averyt, Babbili, and Loeb. The motion passed 6-3.

Regent Loeb made a motion to amend the motion to suspend the tuition increases for FY 25-26 and FY 26-27 academic years to only FY 25-26. Regent Averyt seconded the motion. There was further discussion about this motion among the Regents and Dr. Escamilla. There were no public comments. A vote was taken by show of hands, with 4 voting in favor by Regents Averyt, Adame, Babbili, and Loeb,

and 5 voting against by Regents Scott, Crull, Kelly, Garza, and Turner. The motion failed 5-4.

Dr. Halcomb provided information regarding a new Associate of Applied Science (AAS) degree in Cosmetology. The degree builds upon an existing successful Level 1 Cosmetology certificate program.

Current Program & Proposal: The College currently offers a Level 1 certificate requiring 33 semester credit hours, allowing graduates to take the Texas Department of Licensing and Regulation (TDLR) exam. The proposed AAS degree adds 27 credit hours, including 12 in advanced cosmetology, 5 general education core courses, and additional courses to bring the total to 60 credit hours. This provides a pathway to a Bachelor of Applied Science in Organizational Management Leadership (BAS-OML), beneficial for those aiming to own a salon. The AAS is presented as a career advancement pathway.

Dr. Sramek outlines how the certificate prepares students for entry-level positions like hair stylist or skincare specialist, while the AAS degree is preferred for supervisory roles. The additional business courses within the AAS are geared towards preparing students for salon ownership. Stakeholder feedback (advisory committee, salon owners, high schools) strongly supports the AAS program. High schools are enthusiastic, with plans to allow students to complete the AAS by high school graduation. Faculty are also supportive, seeing it as a way to advance student skills and create a pool of qualified educators. The program addresses a high demand, as evidenced by the College's high enrollment numbers compared to other Texas colleges offering similar programs, and the projected increase in demand.

The College currently has the necessary faculty, lab assistants, classroom and lab space to support the program. Additional adjunct faculty will be hired to meet increasing demand. High schools may also teach some courses if they meet the criteria. Conservative budget projections anticipate 10 new students in year one, increasing by five each year, with funding for two adjunct faculty and instructional supplies. The program is projected to generate \$669,000 in net revenue by year five, with House Bill 8 funding of \$3,500 for the certificate and \$4,500 for the AAS.

The program will allow students with licenses from other institutions to transfer credits. The Board discussed the potential for granting a certificate upon credit transfer, mirroring a previous discussion on a similar issue with a welding program. A proposed

marketing plan involves contacting all licensed cosmetologists in the service area. Next steps include obtaining approval from the coordinating board, notifying SACSCOC, and developing a marketing plan.

Dr. Halcomb and Dr. Sramek responded to questions from the Board of Regents.

Regent Babbili made a motion to approve the Associate of Applied Science in Cosmetology Degree as presented. Regent Loeb seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

Mr. Strybos explained that Texas Education Code, Section 130.066, Automatic Annexation of Certain Territory, allows Del Mar College to annex property as the City of Corpus Christi annexes new property. On December 10, 2024, the City of Corpus Christi annexed property under Ordinance No. 033533. The City also dis-annexed property under Ordinance No. 033534 for property located at or near Nueces Bay Blvd. and Broadway Street for the inner harbor seawater desalination treatment plant. Staff recommendation is to annex the property annexed by the City of Corpus Christi on under Ordinance 033533 and dis-annex property under Ordinance No. 033534.

Mr. Strybos responded to questions from the Board of Regents.

Regent Loeb made a motion to approve the annexation and dis-annexation adopted by the City of Corpus Christi as presented. Regent Kelly seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

Dr. Villarreal presented information regarding a resolution for the 89<sup>th</sup> Texas State Legislative Priorities/Focus Areas. She presented the Texas Association of Community Colleges (TACC) and Community College Association of Texas Trustees (CCATT) shared policy priorities and legislative focus areas. She also discussed the initiatives aimed to enhance student success, strengthen workforce development, and amplify the transformative impact of Texas community colleges. The resolution aims to demonstrate the unified support of 450 community college boards across Texas for several priorities which include full funding for the next biennium and includes a private funding for four-year institutions as part of our new funding metrics and continued support of partnerships across the state and country in order to support our workforce.

Dr. Villarreal and Dr. Escamilla responded to questions from the Board of Regents.

Regent Crull made a motion to adopt the TACC/CCATT Resolution as presented. Regent Loeb seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, amongst Regents present, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

At 3:05 p.m., the Chair announced that the Board was going into Closed Session.

#### CALL TO ORDER/QUORUM CALL

Chair Scott called the meeting to order with a quorum present. She requested a moment of silence followed by the Pledge of Allegiance and Del Mar College Vision Statement.

**GENERAL PUBLIC COMMENTS** – The public was given the opportunity to provide public comments (both general and specific to any agenda item).

There were no public comments.

#### **ITEMS OF BUSINESS:**

Dr. Escamilla provided introductory comments regarding a tuition pilot program initiative that is possibly a historic policy shift for the Board of Regents and the College. He also thanked the entire team that worked many hours in preparing the presentation.

1. Discussion and feedback on the Tuition and Fee Waiver Pilot Program

Ms. Lenora Keas and Mr. Raul Garcia

(II: Elevate, Goal 2: Maximize resources entrusted to the College)

Ms. Keas reiterated that the vision for today's proposed Tuition and Fee Waiver Pilot Program was initiated by Dr. Escamilla. She introduced some of the team members and thanked them for their hard work and dedication.

The key elements discussed:

- 1. <u>Introduction and Acknowledgements:</u> The program is described as a potentially historic policy shift aimed at changing the educational attainment trajectory of the community.
- 2. <u>Vision and Goals of the Pilot Program:</u> The program's vision, initiated by Dr. Escamilla, draws inspiration from similar programs at Alamo College and Austin Community College (ACC). The goals extend beyond just financial aid and include reducing student financial barriers, accelerating student time to completion, elevating wraparound student support services to improve student success, and accelerating the College's response to regional labor market needs by quickly delivering a trained workforce.
- 3. <u>Pilot Program Structure</u>: The pilot program is a one-time cohort launching in Fall 2025, covering a three-year period. The funding will come from donations through the Del Mar College Foundation and funding generated through pathways created by House Bill 8 (HB8), a state initiative providing funding based on student credentials.
- 4. <u>Target Cohort:</u> The target cohort consists of students from the graduating class of May 2025, living in the taxing district. The program is open to adult learners and First-Time-In-College (FTIC) students. Students must have 12 credit hours or less upon entering the program. Participants must commit to attending full-time (12 credit hours) and maintain a 2.0 GPA. The program aims to transition part-time students to full-time status.
- 5. <u>House Bill 8 Funding</u>: Discussion was held regarding how different degree paths are funded under HB8. Associate of Applied Science (AAS) degrees, particularly in fields like Welding, offer opportunities for additional funding through certificates and licensures. Associate of Arts (AA) and Associate of Science (AS) degrees receive funding upon

completion of 15 credit hours and upon graduation. The College receives funding each time a student completes a milestone along their educational journey.

- 6. <u>Marketing and Communications Plan:</u> The College has developed a comprehensive marketing and communication plan to reach different market segments.
- 7. <u>Advising and Student Support Program:</u> The College offers a variety of student support services, including: personal, social, career, and academic advising; degree planning; tutoring, access and advocacy services, career development, mental health counseling, veteran services, and community resource referrals; students in the pilot program will be identified with a specific code to monitor their progress. The College utilizes a pathway-based advising model, aligning programs into eight meta-majors. Full-time faculty and embedded advisors provide advising services. Colleague and Civitas analytics software are used to support advising efforts.
- 8. <u>Del Mar College Foundation Support</u>: The Del Mar College Foundation has pledged one million dollars from funds previously raised through the Viking Promise Program to support the pilot, paying out \$500,000 per year. The Foundation is considering additional support and recognizes the continued need for scholarships for students not participating in the program.
- 9. <u>Timeline and Application Process</u>: The scholarship application process opened on February 1st. The application for the pilot program will open on April 1st and remain open until August 1st. The scholarship application deadline is April 30th. Financial aid applications can be submitted throughout the year, with Pell Grant applications accepted until August 1st. The tuition waiver will be applied upfront, with other financial aid dollars going towards books and living expenses. The application process is primarily for determining eligibility (meeting the program's requirements) rather than a competitive selection process.
- 10. <u>Eligibility Questions and Waivers</u>: The flexibility regarding the 2.0 GPA requirement and changing majors is discussed. Students must maintain a 2.0 GPA to continue in the program. There is some flexibility for exceptions, handled on a case-by-case basis. Students are discouraged from changing majors, with one change allowed. The importance of adhering to the program's parameters is emphasized to accurately assess its impact and suggests caution against waiving requirements too readily. A concern is stated that enrollment could limit capacity in constrained programs, such as nursing, and would unfairly favor pilot program students.
- 11. <u>Assessment Plan:</u> An assessment plan is in place to track the progress of the pilot cohort. Data will be gathered and collected each semester, tracking completion rates and

program enrollment. The College aims to transition students from part-time to full-time status and accelerate their time to graduation.

- 12. <u>Financial Parameters and Sustainability:</u> The pilot program aims to be financially sustainable with a balanced budget for each of the four years. Funding will come from state performance dollars earned by the cohort and contributions from the Foundation. The estimated total state funding is \$3.2 million, combined with the \$1 million from the Foundation. This total of \$4.2 million will offset the cost of waiving tuition and fees (\$2.4 million), resulting in a net of \$1.8 million. The net surplus could be used towards a future cohort or to fund the College's Maintenance & Operations (M&O) budget. Enrollment estimates were made for full-time students (416) and certificate programs (170) to model earnings. The Foundation money is used up front to get the program started, and the expectation is that completion money from previous years will fund subsequent years.
- 13. <u>Dual Credit Considerations</u>: Discussion of how dual credit transfer performance funding is factored into the financial model. The \$930,000 of dual credit transfer dollars is included in the 2026 financial projection. The discussion reveals that the model initially incorporates dual credit earnings from both the pilot cohort students and other non-participating students. The budget is for one cohort only, and it will become a revolving cycle after the first year. The performance targets are set by outcomes from the 2023-2024 year.
- 14. <u>Program Evaluation</u>: Initial program outcomes include increasing student graduation rates. The outcomes were observed at both ACC and Alamo Community College. The pilot program may accelerate training for the Regional Labor Market. ACC saw a 17% increase in freshman enrollment from the pilot program.

The College will present progress reports to the Board in the spring semester.

The Regular Meeting of the Board of Regents of the Del Mar College District convened on Tuesday, March 4, 2025, at 1:00 p.m., at the Center for Economic Development, 3209 S. Staples, Room 106, Corpus Christi, Texas with the following present:

#### CALL TO ORDER/QUORUM CALL

Chair Scott called the meeting to order with a quorum present. She requested a moment of silence followed by the Pledge of Allegiance and Del Mar College Vision Statement.

**GENERAL PUBLIC COMMENTS** – The public was given the opportunity to provide public comments (both general and specific to any agenda item).

There were no public comments.

#### **RECOGNITIONS:**

Dr. Rivera stated the College was recognized as a finalist in the 2025 Bellwether Awards. He acknowledged Mr. Paul Creacy, Ms. Rachel Benavides, and Ms. Rebecca Salinas. The College was a finalist in the proposal for stackable awards under Workforce Development category. He provided further background information and then introduced Mr. Creacy.

Mr. Creacy provided further detailed information regarding the stackable credentials proposal which came from looking at what students need and identify which pathway they need to take and how the credentials stack up in their educational plan based on their dreams.

 Selection of Students to Texas Two-Year College All-State Choir and All-State Band for Performances at Texas Music Educators Association Convention and Student Rufino Medado, Freshman Tuba Player, won the Concerto Competition.

Dr. Halcomb recognized the College's students who were selected to the Texas Two-Year College All-State Choir and All-State Band for Performances at Texas Music Educators Association Convention. She introduced each student and the instrument they played. She also introduced Dr. Mirae Lee, Dr. Raphael Rada and Professor Cynthia Longoria for their dedication and commitment to the students to prepare them for this competition.

#### COLLEGE PRESIDENT'S REPORT...... Dr. Mark Escamilla

• February 18, 2025: TACC CEO Monthly Call (I: Communicate, Goal 2: Connect Beyond the College)

Dr. Escamilla attended the Texas Association of Community Colleges CEO monthly call. These calls are made to stay in close contact with the association leadership.

• February 9-12, 2025: National Legislative Summit, Washington DC (I: Communicate, Goal 2: Connect beyond the College)

Dr. Escamilla attended the National Legislative Summit in conjunction with the Association of Community College Trustees with Chair Carol Scott, Regent Anantha Babbili, and General Counsel Augustin Rivera, Jr.

#### **REGENT'S REPORT:**

Chair Scott reported that she and Dr. Escamilla met with Representative Cloud. They spoke about legislative priorities which included an impact statement of federal dollars at our campus. She advised that ACCT is sending a weekly law alert and suggested the Board signup to be kept abreast of quickly changing information.

• February 9-12, 2025: National Legislative Summit Meetings......Dr. Anantha Babbili ACCT India-US Workforce Development Partnership Coalition

(I: Communicate, Goal 2: Connect beyond the College)

Dr. Babbili stated he was appointed to the ACCT Finance and Audit Committee and provided information of the committee's work. He and Mr. Rivera met with Senator John Cornyn and discussed their concerns regarding federal funding and Pell Grants. He stated the initiative Cognizant Philanthropies, an IT company based in India that has a major presence in the United States fund the initial phase of the partnership between them and the US. The partnership looks at how students and faculty find some common elements that launch them into the future – what happens in 10, 20 years from now.

Mr. Augustin Rivera, Jr., General Counsel, stated he helped facilitate a community college roundtable discussion regarding AI and that he and Dr. Babbili met Senator John Cornyn in a meeting with the Texas delegation. Mr. Rivera stated that Senator Cornyn spoke about community colleges and his first words were, "I'm a big supporter of community colleges because of two things. You all are affordable and you're relevant. You provide relevant education to students." Another positive note, Senator Cornyn stated he was a fan of dual credit. He has a personal connection with Del Mar College in that his father, a World War II veteran, graduated from Del Mar College.

Mr. Loeb echoed Dr. Babbili's previous sentiments and stated there was a general sense that Del Mar College is a step or two ahead of a lot of other schools. He stated there was discussion regarding barriers and how students didn't feel like they belonged. He stated that to continue to be successful, the College must continue to work on making sure that everyone feels welcome. DMC has a huge advantage in that the student body matches our population and believes the College should continue to build on that.

#### **STAFF REPORTS:**

Dr. Villarreal presented a high-level overview of Del Mar College's advocacy efforts, emphasizing the importance of staying informed, building relationships with legislators and their staff, and focusing on key legislative priorities, particularly those related to House Bill 8 and its implementation at both the federal and state levels.

For the federal level – She addressed the speculation about the future of the Department of Education under the new administration. The two main functions of the Department of Education: policy making to support student success and financial management of federal dollars (grants and loans). She stated that the College is closely monitoring communication from the White House regarding changes to the Department of Education.

For the state level – She emphasized the importance of advocacy for community colleges which have over 700,000 students in Texas. Focus is being put on communicating and educating new legislators, Senator Adam Hinojosa and Representative Denise Villalobos, regarding House Bill 8 and the College's appropriations.

Dr. Villarreal and Dr. Escamilla responded to questions from the Board of Regents.

Mr. Garcia reported that the College has historically monitored external factors to identify risks to property tax revenue which includes tax collections, property valuations, legislative changes, and property tax litigations and appeals.

Mr. Garcia highlighted the importance of property taxes to Del Mar College, noting that they account for 62% of the College's three combined funding sources. He contrasts this with other Texas community colleges that are more reliant on state funding or, in one unusual case, tuition and fees.

Mr. Garcia provided specific trends in property valuations, focusing on single-family homes, which represent a significant portion (48% in 2024) of the total property valuations. He notes the growth in single-family home valuations since 2020. The College also experienced a spike in valuations in 2023, leading to an increased number of valuation protests, particularly from petrochemical companies. These protests were settled in 2024, resulting in a slight decrease in overall property valuations.

Ms. Jackie Landrum discussed property tax collection rates, focusing on the collection rate based on the College's budget, which accounts for lawsuits, protests, tiffs, and penalties/interest. She reported that as of the end of January, the collection rate was slightly lower than the previous year, but by the end of February, it reached 98.2%, consistent with historical trends.

Ms. Landrum also connects the fluctuations in taxable property valuations with the number of appeals filed. The significant increase in property valuations from 2022 to 2023 led to a substantial rise in appeals. However, the subsequent decrease in valuations in 2024 resulted in fewer appeals.

#### REGULAR AGENDA

Agenda Item No. 4 was tabled.

Mr. Strybos explained that Texas Education Code, Section 130.066, Automatic Annexation of Certain Territory, allows Del Mar College to annex property as the City of Corpus Christi annexes new property. On February 18, 2025, the City of Corpus Christi approved an ordinance to annex 63.239-acre tract of land located along the east side of

County Road 33, London Pirate Road. Staff recommended annexing the property annexed by the City of Corpus Christi on February 18, 2025.

Regent Garza made a motion to adopt the annexation. Regent Babbili seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

Mr. Strybos explained that Texas Education Code, Section 130.066, Automatic Annexation of Certain Territory, allows Del Mar College to annex property as the City of Corpus Christi annexes new property. On February 11, 2025, the City of Corpus Christi approved an ordinance to annex and rezone land owned by an Anil C. and Vandana A. Patel for the Padma Estates Subdivision, a 19.2-acre track located along the north side of FM 2444. Staff recommended to annex the property annexed by the City of Corpus Christi on February 11, 2025.

Regent Babbili made a motion to adopt the annexation. Regent Kelly seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

Discussion was held among the Regents regarding annexing the whole London School District.

Mr. Strybos stated he has been working on the State Energy Conservation Office Utility Cost Reduction Measures loan. The is a \$6 million loan with an 2.5% per annum interest rate for 11 years that's tied into the life of the equipment. The estimated loan repayments, and that's using the \$6 million, 11 years, and 2.5%, is approximately \$624,452 per year, and that would be funded from the operating budget based on the

utility cost reductions. He discussed the projects that would be improved by this loan including upgrading the College's Energy Management System.

Mr. Strybos responded to questions from the Board of Regents.

Regent Kelly made a motion to authorize Administration to negotiate with SECO for the SECO LoanSTAR loan. Regent Loeb seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, with Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

Chair Scott stated that the Audit Committee is the only established committee, but the Board can add additional committees at a later point in time.

Regent Babbili made a motion to re-establish the Audit Committee and confirm that there are no other Board committees. Regent Averyt seconded the motion. There was no further discussion from the Board. There were no public comments. A vote was taken by show of hands, and the motion carried unanimously 9-0, Regents Scott, Adame, Averyt, Babbili, Crull, Garza, Kelly, Loeb, and Turner in favor.

Mr. Rivera stated the presentation aims to reinforce the importance of ethical conduct and compliance with bylaws, drawing upon established principles from organizations like ACCT, AGB, and SACSCOC. It also highlights the potential pitfalls of unethical behavior in higher education and offers guidance on navigating complex ethical dilemmas.

Mr. Rivera acknowledged the Regents' commitment to ethical behavior and thanked them for participating in the annual ethics review, and the Regents have been performing annual ethics reviews for over 10 years. The current review and

update process is the product of updated rule changes stemming from the 2021 Ad Hoc Committee review.

Mr. Rivera stated Dr. George Boggs' wrote a book about 15 years ago, "Ethical Leadership in the Community College," which highlights the privilege and responsibility of leadership, emphasizing the need to honor the public trust and make ethical behavior a core value to prevent ethical lapses. He reviewed recent headlines that illustrate the consequences of ethical failures in community colleges across the country, including feuds, ethics violations by trustees, controversial spending, conflict of interest concerns, and faculty votes of no confidence. These issues can damage functionality, credibility, and reputation.

Mr. Rivera reviewed the ethical standards from authoritative bodies and discussed Board policy and read the Del Mar College Statement of Conduct and Ethics.

Mr. Rivera connected the ethical review with the College's strategic plan and values – integrity, courage, resourcefulness, community, empathy, and tradition.

Mr. Rivera concluded his presentation and quoted Ms. Barbara Jordan, "being honest, telling the truth, and doing what you said you would do" to reinforce the core of ethics of the Board of Regents.

Each Regent signed and dated the Code of Ethics form at this meeting.

Mr. Rivera responded to questions from the Board of Regents.

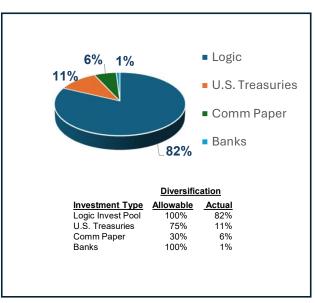

**SUMMARY:** Del Mar College Purchasing and Business Services Department has advertised for Del Mar College Workforce Development Center – Aransas County. This solicitation is a Competitive Sealed Proposal (CSP) or Qualifications based procurement. This project consists of renovating the interior of the existing structure to become the Del Mar College Workforce Development Center – Aransas County.

BACKGROUND: Aransas County received an Economic Development Grant to renovate a building to be a Workforce Development Center that would be operated by Del Mar College. In 2024 Aransas County requested the Grant be reassigned to Del Mar College. Del Mar College Physical Facilities Department has worked with Turner Ramirez Architects and DBR Engineering to complete the 100% Construction Documents. The project will be completed within 210 calendar days. This project will be funded by the EDA Grant funds. Administration has worked with the adjoining property owner such that the proposed Blue Wave Car Wash will not impact Workforce Development Center Operations. The renovated 16,000 Gross Square Foot Building will include thirteen classrooms.

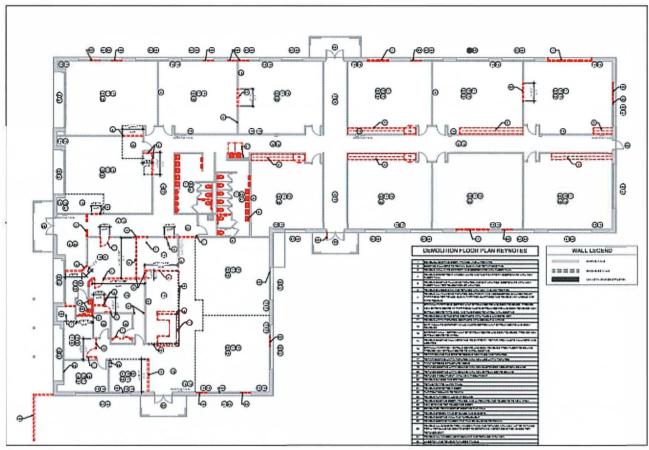


Figure 1 DMC-WDC--Aransas County Floor Plan

#### **SUMMARY:**

In accordance with Texas law and DMC policy, the Board of Regents, on the recommendation of the Chief Executive Officer, may grant tenure to qualified faculty members.

I recommend that tenure be conferred on the specific faculty members listed on the attached April 1, 2025 memorandum from Dr. Jonda Halcomb, Vice-President and Chief Academic Officer.

#### **BACKGROUND:**

The 88<sup>th</sup> Texas Legislature amended the Texas Education Code to authorize the Board of Regents of an institution of higher education to approve tenure decisions, "on the recommendation of the institution's Chief Executive Officer."

Accordingly, the College amended its policies to provide:

B6.7.2.1.1 The Board of Regents of Del Mar College, on the recommendation of the Chief Executive Officer, may grant tenure.

B6.7.7 Granting of Tenure: By May 1 of each year, the CEO of the College shall recommend to the Board of Regents those faculty members that have met the requirements to be considered for Tenure.

As reflected in the April 1, 2025 attached memorandum from Dr. Halcomb, the qualifications of the individuals recommended for tenure have been thoroughly reviewed and are ready for consideration by the Board and I hereby recommend the granting of tenure for these individuals.

#### RECOMMENDED ACTION:

Based on the CEO's recommendation, the Board approve the granting of tenure to the faculty members identified in Dr. Halcomb's April 1, 2025 memorandum.

**B6.7 Tenure: Revised June 11, 2024** "Tenure" means the entitlement of a faculty member of an institution of higher education to continue in the faculty members academic position unless dismissed by the institution for good cause in accordance with the policies and procedures adopted by the institution. Texas Education Code: Section 51.942(a)(4)

**B6.7.1 Application:** The tenure provisions stated hereafter apply only to regular full-time instructional faculty members (also referred to as tenure-track faculty); that is, those holding academic rank as faculty and librarians. Tenure is not applicable to term appointments.

B6.7.1.1 Persons who perform some instructional duties as well as some administrative duties shall not be covered by tenure provisions unless their services related to the instructional program constitute more than half-time employment or unless they are designated by the Chief Executive Officer (CEO) of the College as instructional faculty members for tenure purposes.

B6.7.1.2 Persons who have achieved tenure relinquish it upon acceptance of a

**B6.7.1.2** Persons who have achieved tenure relinquish it upon acceptance of a non-tenured position with the College.

**B6.7.1.3** The granting of tenure may not be construed to create a property interest in any attribute of a faculty position beyond faculty member's continuing employment, including regular annual salary and any privileges incident to status as a tenured professor.

**B6.7.2 Probation:** When the administration appoints a person to the rank of regular full-time Instructor or to a higher rank, the administration shall inform that person in writing that the appointment is probationary until tenure is granted. Term appointments are not tenure-track positions.

**B6.7.2.1** The probationary term of service at Del Mar College shall be six (6) academic years, except in the event of earlier promotion under B6.6.

**B6.7.2.1.1** The Board of Regents of Del Mar College, on the recommendation of the Chief Executive Officer, may grant tenure.

B6.7.2.1.2 Tenure track faculty employed and promoted by the College during the 2011-2012 academic year, pursuant to B6.6, will be classified as "tenured," as defined by B6.7, as of September 1, 2012, without further review and promotion.

**B6.7.2.2** Years of service at other institutions and leaves of absence shall not be subtracted from the probationary period.

B6.7.2.3 The number of years of credit related to tenure need not be the same and may be fewer than the number of years of experience recognized for salary computation purposes and/or for service awards.

B6.7.2.4 Each year, Chairs, Deans and the Chief Academic Officer (CAO) may consult with the CEO of the College regarding the renewal or non-renewal of the one year contract of probationary, tenure track faculty. The decision to reappoint or non-reappoint shall be made in the discretion of the CEO of the College as provided at B5.10.2.1.

B6.7.3 Non-reappointment of Tenure Track Probationary Faculty: Notice of non-reappointment or of intention not to reappoint a non-tenured, tenure track probationary faculty member shall be given in writing as follows:

B6.7.3.1 The notice shall be given no later than March 15 of any academic year of probationary service, and the appointment shall expire at the end of the academic year in which notice is given.

B6.7.3.2 Chairs, Deans and the CAO may consult with the CEO of the College regarding the renewal or non-renewal of the one year contract of probationary, tenure track faculty. Decisions to renew or non-renew the one year contract of probationary, tenure-track faculty shall be in the discretion of the CEO of the College. Probationary, tenure-track faculty shall have no right, expectancy, claim, or entitlement to employment beyond the one year period of time specified in the contract. Prior renewals of the probationary renewing term contract do not establish a right, expectancy, claim, or entitlement to employment beyond the period of time specified in the contract.

B6.7.4 Requirements for Tenure Eligibility Recommendation: In order to receive service credit towards promotion/tenure for the first year of employment, a faculty member must have been hired prior to Nov 1 of their first academic year. The following requirements must have been completed in order for a faculty member to be recommended for tenure:

B6.7.4.1 The faculty member must have completed five (5) academic years of the probationary period; i.e., the faculty member must be in the sixth (6th) academic year of the probationary period, except in the event of earlier promotion under B6.6.

B6.7.4.2 The faculty member must have successfully completed the process for promotion at B6.6 and have met the requirements set forth therein.

B6.7.5 Procedures for Tenure Eligibility Recommendation: At the beginning of the sixth (6th) year of probationary status, the faculty member shall be notified by the appropriate Dean to prepare for a comprehensive evaluation by the

faculty members Chair by November 15 except in the event of earlier promotion under B6.6. The promotion process set forth in B6.6 shall be utilized by the Chair, Dean, and the Chief Academic Officer (CAO) in making a tenure recommendation.

B6.7.6 Recommendation for Tenure: The faculty member shall be recommended for tenure in writing by the Chair to the Chief Executive Officer (CEO) through the appropriate Dean and the CAO as provided by the process in B6.6. The recommendations shall be made in the faculty member's sixth (6th) year of probationary (tenure-track) service, except in the event of earlier promotion and tenure eligibility under B6.6.

**B6.7.7 Granting of Tenure:** By May 1 of each year, the CEO of the College shall recommend to the Board of Regents those faculty members that have met the requirements to be considered for Tenure.

**B6.7.8 Notification of Granting of Tenure:** The CEO shall notify successful candidates that they are being granted tenure effective with the beginning of the coming academic year--the beginning of the seventh (7th) academic year of service, except in the event of earlier promotion under B6.6 and upon granting of tenure by the Board of Regents.

**B6.7.9 Appeal:** Probationary faculty member may appeal the denial of promotion and/or tenure eligibility as provided at A6.6.9 at the time promotion and/or tenure eligibility is denied.

**B6.7.10** Reapplication and Procedures for Tenure After Non-Approval from Board of Regents: Eligible faculty that meet all requirements to apply for tenure, receive a recommendation by the CEO and are denied tenure by the Board of Regents, may reapply for tenure consideration in the following academic year, provided that eligibility requirements are still met. Procedures in B6.7.5 will be utilized for reapplication.

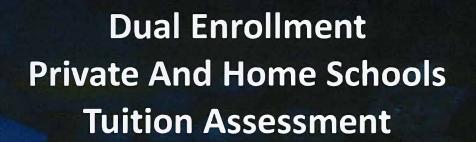

SUMMARY: In accordance with the Texas Education Code, Section 130.066, Automatic Annexation of Certain Territory, as the City of Corpus Christi annexes property, then Del Mar College may also annex the property.

BACKGROUND: On March 18, 2025, the City of Corpus Christi approved an Ordinance annexing and rezoning a two-acre tract of land owned by Texas Lone Star Abstract & Title Investments Group, LLC, located at the southeast comer of Farm-to-Market (FM) 43 and County Road (CR) 47 (the "Property"); annexation of an approximately 300 linear-foot section of CR 47 right-of-way abutting the Property's western boundary; and annexation of an approximately 2,490 linear-foot section of FM 43 right-of-way located between the Property's eastern boundary and London Pirate Road. Approving the related service plan; adding the annexed area to City Council District 3; rezoning the 2.00 acres from the "FR" Farm Rural District to the "CN-1" Neighborhood Commercial District.

**RECOMMENDATION:** Annexation of the property as annexed by the City of Corpus Christi.
